

## Official Contest Rules – KNEX – 12 Days of Christmas!

1. **NO PURCHASE NECESSARY TO PARTICIPATE OR WIN. VOID WHERE PROHIBITED, SOME RESTRICTIONS APPLY. Open to Laredo residents only.**
2. **SPONSORS:** MBM Texas Valley, LLC dba R Communications LLC, including station **KNEX "Hot 106.1"** located at **107 Calle del Norte Rd Suite 212, Laredo, Texas 78041** (the "Station").
