

## Official Contest Rules – KNEX/KQUR – Pick Your Purse!

- 1. NO PURCHASE NECESSARY TO PARTICIPATE OR WIN. VOID WHERE PROHIBITED, SOME RESTRICTIONS APPLY. Open to Laredo residents only.**
- 2. SPONSORS:** Radio United, LLC, including station **KNEX "Hot 106.1" and KQUR Digital 94.9"** located at **107 Calle del Norte Rd Suite 212, Laredo, Texas 78041** (the "Station"). The administrator of the Contest is **Radio United, LLC. The Outlet Shoppes at Laredo is the promotional sponsor of this Contest.**
- 3. DATES OF THE CONTEST: "Pick Your Purse"** (The "Contest") begins on November 8<sup>th</sup>, 2021, and ends on November 26<sup>th</sup>, 2021. Specific times and locations will be announced on-air.
